CEU INFORMATION

Question: Will CEUs be available?

Answer: Yes, each session is CEU eligible and can be used towards obtaining a maximum of 0.9 CEUs for the Conference.

Question: What are the CEU requirements for each day?

Answer: Please see the following breakdown for the required hours each day to obtain CEUs:

- **Wednesday:** Afternoon portion 1 hour PLUS remaining afternoon 2 hours for a total of 3 hours and 0.3 CEUs
- **Thursday:** Morning portion 1 hour PLUS afternoon 2 hours for a total of 3 hours and 0.3 CEUs
- **Friday:** Morning Presentation – 3 hours for 0.3 CEUs

**IF YOU DO NOT COMPLETE ALL THE REQUIRED HOURS FOR EACH DAY
YOU WILL NOT BE ABLE TO COLLECT CEUs.**

Question: How many tracks are available for the technical sessions?

Answer: Wednesday afternoon and Friday morning there will be portions where only (1) session is available and must be attended to receive CEUs. Technical sessions for Wednesday afternoon and Thursday morning AND afternoon will feature up to three (3) tracks – Water Treatment, Wastewater Treatment and Distribution/Collection. Delegates must attend one (1) session from the available three (3) to obtain CEUs.

Question: What disciplines do Water Week CEUs apply to?

Answer: CEUs approved for the Conference apply to all FOUR disciplines. (Does **not** apply to Pre-Conference Workshops. Specific disciplines will be listed on the workshop registration page).

Question: How will I keep track of the technical session I want to attend each day?

Answer: We recommend using the 'Schedule' tab on the Sched web app to create your own personal schedule and mark down all the sessions that you attended. You can check off the sessions you attend on the app as well as in your printed program from your registration package.

Question: How is attendance tracked for CEUs?

Answer: Each operator will be responsible to keep track of the sessions they attend for CEU tracking.

A CEU form is included in your delegate registration package. Once the Conference has concluded, each delegate can complete and sign their form to upload to Compliance365.
