- Performs sampling and testing of wastewater, sludge, and water to meet regulatory standards and maintain optimal treatment performance.
- Identifies and troubleshoots operational issues, implementing corrective actions to prevent and minimize process disruptions.
- Collects and analyzes samples, maintains accurate records, and monitors test results to support compliance and operational efficiency.
- Ensures adherence to the City's Alberta Environmental Protection Operating Approval by maintaining compliance with all relevant environmental regulations and standards.

- Sound theoretical and practical knowledge of methods, materials, tools, and equipment used in wastewater treatment operations and maintenance.
