- Integration of SCADA software (GE iFIX) with Control Systems.
- Maintain PLCs, HMIs and OT network equipment including Allen-Bradley PLCs, SCADAPack, Red Lion HMI, Siemens PLCs, and other automation systems.
- Assist with documentation and standards creation.
- Must be willing to work overtime as needed, including after-hour emergencies when necessary.
- Working alone and participating in the stand-by schedule.
- Travelling and overnight stays at remote worksites may be required.
- Other duties as assigned.

The successful candidate must be eligible to work in Canada without limitations and, will:

- Have a Diploma in Instrumentation Engineering Technologist from an accredited institution, or;
- Journeymen Instrumentation Technician Certification, (apprentice may be considered) or;
- Journeymen Electrician Certification with instrumentation experience
